# ANNEX 3B EXEMPTION FROM THE PRINCIPLE OF TERRITORIALITY

Treatment of Operations and Processes Performed outside the Territories of the Parties

- 1. In determining the originating status of a good included in this Annex, operations and processes performed in the Gaeseong Industrial Complex located in North Korea, on materials exported there from Korea and subsequently re-imported to Korea, shall be considered to have been performed in the territory of Korea, provided that the total value of non-originating input<sup>1</sup> does not exceed 40 percent of the FOB price of the good.
- 2. Except as otherwise provided in this Annex, this Chapter and Chapter Four (Origin Procedures) shall apply *mutatis mutandis* to the originating status of a good included in this Annex. Accordingly, a good shall be treated as non-originating if it does not satisfy all applicable requirements set out in Articles 3.1 through 3.14 and Annex 3A.

## Origin Procedures

- 3. An exporter or producer who declares that a good qualifies as originating on the basis of paragraph 1 shall make such a reference in the Certificate of Origin.
- 4. Each Party shall assist the competent authority of the importing Party to conduct verification on the goods included in this Annex, in accordance with Article 4.8 (Verification).

#### Review

- 5. When a Party requests an amendment or modification to the list of the goods included in this Annex, the other Party shall give sympathetic consideration to such a request and provide opportunities for consultations. The other Party may request information as it considers necessary for such consideration. If the Parties agree to amend or modify the list of the goods, they may take a joint decision at the Joint Commission to amend the list.
- 6. Upon request of a Party, the Parties shall review the implementation of this Annex. Either Party may request information as it considers necessary for such review. Taking into account the result of the review, the Parties may take a joint decision at the Joint Commission to amend or modify this Annex.

### Suspension of the Application of this Annex

7. When a Party considers that an originating good included in this Annex is being imported under preferential tariff treatment into its territory in such increased quantities and under such conditions as to cause, or threaten to cause, serious injury to its domestic industry, the Party may suspend the application of this Annex to the good for a period of time as it

considers necessary to prevent or remedy such injury or threat thereof to the domestic industry of the Party.

- 8. A Party that intends to suspend the application of this Annex in accordance with paragraph 7 shall notify the other Party two months in advance and afford the other Party an opportunity to exchange views with it in respect of the proposed suspension.
- 9. The period referred to in paragraph 7 may be extended provided that the Party that has taken the action of suspension has determined that the suspension continues to be necessary to prevent or remedy the injury.
- 10. In critical circumstances, where delay would cause damage which would be difficult to repair, the suspension of the application of this Annex under paragraph 7 may be taken provisionally without the advance notification referred to in paragraph 8 to the other Party, on the condition that notification shall be made before such suspension takes effect.
- 11. The Party concerned may suspend the application of this Annex unilaterally and unconditionally after notifying the other Party two months in advance and providing the other Party with an opportunity to exchange views in respect of the proposed suspension in accordance with paragraph 8. In this case, the Party shall not be obliged to prove that there is serious injury, to consult in advance, to limit the duration or frequency of suspension, or to compensate for its action.

# Option of Rescinding

12. Five years following the entry into force of this Agreement, either Party may rescind the application of this Annex when it determines, on the basis of a review and on its own discretion, that its interests have been damaged as a consequence of the application of this Annex.

#### Dispute Settlement

13. Neither Party shall have recourse to Chapter Twenty-Three (Dispute Settlement) for any matter arising under this Annex.
